Chef Tony Finds His Calling

hen Anthony Jonhson came home to his DC apartment in October 2011, it was empty. While he was out of town, his roommate stole everything Anthony owned. For a while, Anthony lived in a rooming house until his landlady made it difficult to stay. He still had his seasonal job doing hospitality work at Georgetown University

but couldn't afford to live on his own. He called Central Union Mission and discovered he qualified to be part of the Mission's Work Program.

Anthony moved into the Mission in February 2012. Only a month later he committed his life fully to Christ during a chapel service. With a tremendous new hunger for prayer and knowledge, he read Josh McDowell's book *More than a Carpenter* and practiced the spiritual discipline of fasting.

When his temporary job ended in early summer, he started as a grill cook at the restaurant at Bethesda Naval Hospital. There he found he could suggest some improvements to bring in more customers. After his trial period impressed his manager, she created a permanent position for him writing recipes, and she gave him his own office. One of his favorite entrée updates is his Holiday French Toast (see page 3.)

With his outgoing personality, he easily made friends with employers and employees at staffing agencies and venues like the Verizon Center and Nationals Park. When his employment agency asked if he could send in 10 potential recruits, Anthony called his brothers at Central Union Mission, and most were hired.

You may also double your impact with your employer's gift-matching program. As well, our community would greatly appreciate unneeded merchandise and supplies from your business. If you are required to take distributions from your **retirement fund**, your donation to the Mission could spare you higher income taxes. **Charitable gift annuities** and **real**

This, he learned, was what God had in mind for him: using his relationships to help match employers with employees. He began helping Mission men network, craft resumes and practice interview skills. "God sent me here to do this for Him. Now I'm just flowing in the Mission, giving without hindrance and getting blessings from Christ by helping others."

Now that he's found a one-bedroom apartment in an Oxford House building, he realizes that "God was setting me up to move out but not to stop helping." He advises the other men to take advantage of all the resources the Mission has to offer: "The Mission's been around for over 125 years—long enough to know what works and what doesn't. Learn to be selfless at the Mission, respect authority and follow the guidelines, and you will see progress."



Chef Tony's Holiday French Toast

- 4 whole eggs
- 1 c. half and half
- 1 t. lemon juice
- 8 oz. coconut milk or coconut cream
- 1 t. cinnamon 1 t. nutmeg

2 T. brown sugar

1 loaf of bread, sliced

Beat eggs until well blended, and then beat in remaining ingredients. Soak bread slices in egg batter, then fry on a greased skillet, flipping to brown on both sides. Serve with Pecan Syrup. (serves 5)

Pecan Syrup

1 stick butter or margarine 2 c. brown sugar 1 c. heavy cream 1 c. pecans

Melt butter in a saucepan, then add sugar and cream, stirring until sugar is dissolved and syrup is smooth. Add pecans, and serve warm over French toast.




A Cold City in Need
