## Donor Stock Giving Instructions

Dear Donor:

Central Union Mission maintains an account with BB&T Bank, to receive non-trust related stock gifts. The donor should notify BB&T of their intention to make a gift of stock to The Central Union Mission. By completing a **Stock Transfer Form (PDF)** your broker can easily transfer stock "stock name" to Central Union Mission.
